Enclosed for the Bureau is one xerox copy each
of referenced letter and letter to Denver Office from MORT
STERN, editor of editorial page of "Denver Post."

Also enclosed is a xerox copy of a news article
and a xerox copy of a letter from one LEON BERGER, 201
Sullivan St., NY 12, NY, which items were attached to the
above referred to letter from Mr. STERN.

A review of NYO indices revealed a reference to
one LEON L. BERGER in NY closed file 100-81653, serial 443,
page 72, which is a NY report of SA GERALD A. MC CARVILLE,
dated 8/12/48 and captioned "LIEUTENANT COLONEL GUSTAW
ALEF-BOLKOWIAK, WITH ALIASES; ET AL; ESP-R." This reference
disclosed that on 5/13/48, [ND 433] made available to the NYO
correspondence addressed to JAN GALEWICZ, Consul General,
Polish Consulate, NYC. One item of correspondence was
a letter dated 5/4/48 from LEON L. BERGER, 201 Sullivan
Street, NY, NY, in which BERGER commended GALEWICZ on a
talk which was given by GALEWICZ on Municipal Radio Station
WNYC, on Sunday, 5/2/48, in honor of Polish Constitution Day.
