On December 10, 1963, PCI THOMAS R. ACKERMAN, Chicago, informed SA WILLIAM F. HOOD, Jr. that about 1948 or 1949 a BOB MULLENIX, a private investigator, had conducted the Wastepaper Handlers Union, Chicago, Illinois. About November, 1962, MULLENIX was killed in an automobile accident and, thereafter, his files were sent to a brother, JOHN C. MULLENIX, 1232 West Maypole South, Springfield, Illinois. These files possibly contained information regarding RUBY's association with DORFMAN.
