On 11/22/63, [NY 2471-S*] who has furnished reliable information in the past, advised that one JAMES TALBOTT, "of Dallas, Texas", was in contact on that date with the office of "The Worker" in New York City. He identified himself as a "friend of Mr. Jackson". TALBOTT suggested that "The Worker" put out an extra on the assassination. He said that he was on a Dallas city bus on 11/22/63 and saw the President's motorcade about three minutes before the President was shot. TALBOTT suggested that the special edition of "The Worker" should blame the "right-wing" John Birch Society and the groups around General WALKER for the assassination.

On 11/27/63, [NY 3903-S] obtained the following information at CPUSA headquarters in New York City:

About two weeks ago, one JAMES TALBOTT, Dallas, Texas, sent a check for \$38.00 to CPUSA headquarters payable to GUS HALL, directing that this money be used for a donation or dues.

PHIL BART, CPUSA Organizational Secretary, directed FANNIE TOOHEY, CPUSA Clerical employee, to make out a receipt for this money and hold it. On 11/27/63, BART indicated he had some misgivings about having accepted this money, from an unknown person, particularly since that person was from Dallas, in view of the President's assassination there.
