On 3/2/64 Sergeant Salvatore Guarnieri, Confidential Squad, Police Headquarters, Rome, Italy, advised that a record was located at the Foreigners Office, Police Headquarters, Rome, for one Demetrio Mohrenschiltd, born April 11, 1902, Hanover, U.S.A. This individual was in possession of U. S. passport No. B288918 issued at Washington, D. C., March 23, 1961. The record indicates this person visited Rome during March, 1962, and lodged at a rooming house in Rome. No further information was available. (u)

It is apparent from the variance in subject George De Mohrenschiltd's name, date and place of birth, and passport, that above individual is not identical with subject. (u)
