Memorandum to Mr. Sullivan Re: LEE HARVEY OSWALD 105-82555



The summary can readily be amended to suit the Commission's needs and at the same time to protect that 15 and 19 and to avoid disclosure of the extent of our investigation in Mexico. This can be accomplished by deleting reference to three items which are not touched upon in the Commission's report and by rewriting an introduction paragraph on page one deleting a specific reference to a confidential source abroad (Legat). The Commission's report on page 304 records that". . . the Government of Mexico initiated a thorough investigation to uncover as much information as possible on Oswald's trip. Representatives of U. S. agencies worked in close liaison with Mexican law enforcement authorities." A slight revision of introductory paragraph on page one will accurately fit the above statement of the Commission.

RECOMMENDATION

It is recommended that to properly protect our operations in Mexico, the 5-18 summary be written in unclassified form as aforesaid. To do this will not require complete retyping. We propose to amend principally by deleting five to six pages and to reproduce the document by Xerox and to renumber the pages.
