The following is a summary of information received from Bureau regarding captioned cases:

On 11/22/63, Bureau instructed that all informants, security, racial and criminal, as well as other sources, be contacted immediately for information bearing on assassination of President KENNEDY. All offices immediately establish whereabouts of bombing suspects; all numerous clan and hate group members, known racial extremists and any other individuals who, on the basis of information available, might possibly have been involved.

Bureau further advised that we are conducting an investigation to determine who is responsible for the assassination and we must follow and resolve all allegations pertaining to the assassination. With regard to information received concerning these cases where it appears Secret Service should be advised, immediately submit same by teletype to the Bureau and immediately follow with dissemination memos.
