Informant furnished a two page, typewritten resume of her conversation with H. THEODORE (TED) LEE. This conversation took place between the informant and LEE on the evening of 3/20/64, and the typed report furnished by the informant has been designated for NY 137-8851. Subsequent to the receipt of this report on 3/23/64, the contents of the report were discussed with the informant on that date. Explanations and entries made in the informant's report are herein set out, and the following information consists of the report furnished by the informant and explanations of the informant's notations as furnished by the informant:

Informant advised that during this conversation she learned that LEE is approximately 37 years of age and is separated from his wife and three children who reside in Florida. LEE supports his wife and the children. LEE is the owner of a Volkswagen and that at the present time the rear end transmission of the auto is being repaired, and the vehicle is being completely refurbished. According to the informant, LEE is having a short wave sending set installed in the vehicle, and it is anticipated the vehicle has been in a state of repair for approximately one month. LEE expects that when the vehicle is finished he is going to Canada on a "hunting trip".

According to the informant, LEE stated he had resigned from the Fair Play for Cuba (FFPC) Committee three weeks prior to the assassination of President JOHN F. KENNEDY, but that he went back to work for the committee to help sort out affairs after the assassination. He stated to the informant that all correspondence regarding the desire of LEE HARVEY OSWALD to establish a chapter of FFPC in Dallas has been turned over to the FBI.

Informant related that when LEE was active in PPFC, the chapters existing and being established throughout the US were his responsibility. Informant related LEE advised that at one time the Socialist Workers Party had been backing PPFC, but had abandoned the committee about one year ago. Informant related the statement of LEE that the aim of PPFC was not communistic or to further communism, but rather to assist in having the state of Cuba recognized in the UN and to reinstate the sugar subsidy formerly granted to Cuba by the US. Informant advised LEE had stated that PPFC sustained their expenses by translating into English and selling copies of all speeches made in Cuba to a total of 1,500 libraries throughout the US. Informant stated LEE had sold two copies of each translation to the interested libraries. LEE also stated that he continues to possess a mailing list of 15,000 people in the US who are interested in PPFC. According to the informant, LEE also stated that translations of speeches in Cuba were made in Czechoslovakia with the use of Czech Government employees and that the translations furnished by the Czechs were found to have been changed in meaning and context when compared with the translations furnished by PPFC.

According to the informant, LEE advised that the magazine "Revolution" seems to be doing very well and is being highly acclaimed. The magazine is published in the English, French and Spanish languages and that the magazine publishers were recently given the sum of \$70,000.00 by the Chinese Communist Government and that the publishers intend at some future date to publish an edition in the Chinese language.

Informant related that LEE advised that some local chapters of PPFC throughout the US were taken over by Trotskyites and that when LEE resigned, the NY branch of PPFC fell apart or disintegrated. (Informant advised that LEE's statement in this regard may have been an expression of his own feeling of importance to the organization that apparently could not exist without him.)

Informant advised that MALCOLM X has been invited to lecture at NY University by MILTON BRAUSS, but that no date has been set for this lecture or speech.

Informant related that according to LEE, a number of individuals previously active in FFPC have more or less become active in the cause of the MAI, which informant understands from LEE stands for Militant Allegiance (or Alliance) for Independence. LEE advised the informant that this is a Puerto Rican organization which to date has been relatively unsuccessful, but whose purpose is to bring about the complete independence of Puerto Rico from the US. Informant related that LEE created the impression that the MAI members are about to arouse and incite incidents along this line. Informant advised that according to LEE, one MARC (last name BLANC or LANG) is the head of this organization and is either affiliated with NY University in some capacity, perhaps as a student, or has a connection with the Socialist Workers Party.

Informant related that statements concerning the assassination of President KENNEDY by individuals previously active in FFPC declare that the President was actually assassinated by police officer TIPPET and that one week before the assassination that Patrolman TIPPET, the Dallas head of the John Birch Society and an unnamed third party, suggested by these FFPC individuals as possibly being OSWALD, were together in JACK RUBY's night club. Informant stated that LEE advised that while OSWALD was an FFPC advocate, that he had also joined a number of anti-CASTRO movements and was thereby in a position to know everything that was going on on both sides of the issues involved.
