On February 4, 1964, Inspector L. R. Parent, Directorate of Security and Intelligence, RCMP Headquarters, said no additional information had been developed to date re OSBORNE. He said it is his understanding the Canadian Consul in New Orleans could furnish very little information and Canadian External Affairs has wired its office in Mexico in an effort to obtain additional information. He also said inquiries are being made through British sources in view of his claimed prior residence in England and investigation is being conducted to establish circumstances surrounding his admission to Canada and in Alberta in view of information in letter written by OSBORNE to the YMCA in Montreal, Quebec. *(C)*
