(u) NY THREE NINE ZERO THREE - S] ADVISED THIS DATE SHE APPEARED AT CPUSA HEADQUARTERS THIS DATE, AT APPROXIMATELY TEN AM. AT THAT TIME SHE WAS IN CONVERSATION WITH JACK STACHEL AND PHIL BART WHO ADVISED HER THAT SHE ~~WOULD~~ SHOULD HAVE BEEN CALLED EARLIER TO THE EFFECT THAT NO BUSINESS WOULD BE TRANSACTED AT THE OFFICE THIS DATE AND THAT THE OFFICE WOULD BE CLOSED. INFORMANT TOLD STACHEL THAT SINCE SHE WAS PRESENT, SHE WOULD BE AVAILABLE FOR ANY ASSIGNMENT NEEDED. SHE WAS ADVISED THAT SHE WOULD NOT BE NEEDED. INFORMANT THEN INQUIRED AS TO THE WHEREABOUTS OF GUS HALL AS SHE HAD NUMEROUS THINGS TO TALK TO HIM ABOUT. STACHEL TOLD HER TO FORGET ABOUT SEEING HALL AS HALL WAS COMPLETELY TIED UP IN VIEW OF THE RECENT EVENTS SURROUNDING PRESIDENT'S RPT KENNEDY'S ASSASSINATION. INFORMANT STATED SHE RECALLED THE NAME LEE OSWALD, AND WHILE AT PARTY HEADQUARTERS THIS DATE, PICKED UP SEVERAL OF HER DICTATION NOTEBOOKS. ON SEARCHING THESE NOTEBOOKS, SHE CAME UPON HER SHORTHAND NOTES REFLECTING A LETTER TO OSWALD. NO ADDRESS IS CONTAINED IN HER NOTES BUT HER BEST RECOLLECTION IS THAT IT WAS SENT TO OSWALD AT IRVING, TEXAS. THE LETTER WAS DICTATED BY ARNOLD JOHNSON, AND
