[NY 554-S*] advised 3/10/67, that RUTH FISHER,
an employee of Tass News Agency (TNA), NYC, attempted to
make reservations for 3/13/67, for LOSEV and HARRY FREEMAN
at the Ramada Inn (PH), Lake Charles, Louisiana. She was
advised there were no openings that date. After several
unsuccessful attempts, FISHER made reservations for LOSEV
and FREEMAN for two single rooms at the "Supreme" (PH)
(or possibly "Capri"), believed to be in New Orleans,
telephone number 504-822-2161.

Source also advised that FREEMAN called Hertz
in New Orleans and reserved a Chevelle or Fairlane in
his name for several days, to be picked up upon arrival
at New Orleans.

* [Source advised that at 4:08 PM, 3/10/67, FREEMAN called JIM MANGDON (PH), believed to be member of Associated Press at New Orleans and advised him that he and LOSEV were coming down next week. MANGDON advised it would be necessary for them to first check in with the Sheriff and be photographed. (S)(u)

* [FREEMAN then called Sheriff HEYD (PH) and identified himself as a representative of TNA in NY. The Sheriff advised him that they would have to appear at his office prior to 5:00 PM to be photographed. (S)(u)

* [FREEMAN said they would make earlier reservations in order to be there. The Sheriff assigned FREEMAN and LOSEV seats number 11 and 12 in the courtroom. (S)(u)

* [FREEMAN then called Delta Airlines and cancelled previous reservations. He made new reservations for himself and LOSEV to depart from NYC on Delta Flight Number 819, departing Kennedy International Airport at 8:40 AM and arriving New Orleans 11:56 AM, 3/13/67. (S)(u)
