THAT GEO. MEYERS, CHAIRMAN, CP, MD. DASH D.C. DISTRICT, DURING CP DIST. BOARD MEETING AT BALTO., MD., NOV. TWENTYSIX, AT APPROXIMATELY TEN THIRTY P.M., STATED THAT HE HAD TO LEAVE FOR N.Y. MEYERS CONFIDENTIALLY ADVISED [BA NINE SEVEN FIVE DASH S] HE HAD TO GO TO NY BECAUSE IT WAS IMPORTANT, MEYERS SAID HE HAD SOME INFORMATION AND A NUMBER OF LETTERS HE HAD TO TURN OVER TO N.Y. BECAUSE OF HIS COMMUNICATIONS WITH TEXAS AND TENNESSEE. MEYERS EXPECTED TO RETURN TO BALTO. NOV. TWENTYSEVEN.
