On 12/9/63 SA 648-S furnished the writer a written report which is located in 134-363A-173, and which contains the following information: (u)

On Saturday, November 23, 1963, at about 6:00 p.m. RENE SANDOVAL was seen arriving at the home of JOHN STANFORD. (u)

STANFORD spoke of the tragic news of President KENNEDY's death and stated that the man who killed President KENNEDY was not a member of the Communist Party. (u)

STANFORD stated that he had never heard of this man who killed KENNEDY. STANFORD stated that Governor CONNALLY will most likely get re-elected after the accident in which he was also shot during the killing of President KENNEDY.

STANFORD's wife stated that now after the killing of President KENNEDY that the Communist Party was being blamed for it, and that JOHN STANFORD will have a hard time with the U. S. Government. (u)

JO STANFORD also stated that she was worried about STANFORD's life being in danger. (u)

STANFORD claimed that he was not worried nor afraid about being harmed. (u)
