ADMINISTRATIVE

Since it appears that MIGUEL FONSECA RIVAS involved ENRIQUE PEREZ BONIN, his son ENRIQUE PEREZ SANCHO, and others in an accusation that LEE HARVEY OSWALD had visited at PEREZ' Hotel in Cuernavaca and they were involved in the plot to assassinate President KENNEDY out of spite, and since FONSECA was in jail during the period when the subject was known to be in Mexico (9/26/63 through 10/3/63), no additional investigation is being conducted and, UACB, FONSECA will not be interviewed.
