(s) At this point, [redacted] (s) brought up the FBI, indicating that it was a "fascist organization" and the enemy of [redacted] (s). He indicated that when LEE HARVEY OSWALD had assassinated President KENNEDY he had been working for the FBI and that the assassination was part of a "fascist" plot in which the FBI was involved. [redacted] (s) continued that they regarded the FBI as an organization to be feared because most of its Agents are very far to the right and many of them are members of the John Birch Society.
