On 5/8/64, [NY 1519-S<sup>2</sup>] (S) who has furnished reliable information in the past, ascertained that VALENTINA DRUZHINA, wife of ALEKSANDR DRUZHININ, Soviet correspondent for "Radio Moscow" in NYC, telephonically dictated to Moscow, USSR, an article concerning an interview of MARK LANE. The article rehashed news items regarding the OSWALD case and pointed out how many persons connected with the case have been killed or committed suicide. The article quoted LANE as saying he needs help to find out who killed President KENNEDY. It also told how LANE was interviewed by two agents of the FBI who asked him for certain documents bearing on the OSWALD case. (S)

The informant did not ascertain who conducted the interview but it would appear that ALEKSANDR DRUZHININ conducted same. (S)(u)

[NY 1519-S<sup>2</sup>] (S) is a highly confidential and sensitive source and any of the above information, if utilized, should be paraphrased in order to protect the informant. (S)(u)
