DEPARTMENT 1960 UNTIL 1970, ADVISED THAT HE RECEIVED A SECOND OF TWO TELEPHONE CALLS ON MARCH 10, 1989, FROM AN UNKNOWN FEMALE WITH A BRITISH ACCENT WHO ADVISED SHE LIVED IN BRIGHTON, SUSSEX COUNTY, ENGLAND, TELEPHONE NUMBER ~~0273-304-361~~, BUT REFUSED TO GIVE HER NAME.

GIARRUSSO ADVISED THAT THE UNKNOWN FEMALE CALLER HAD RELATED TO HIM THAT SHE WAS IN THE NEW ORLEANS AREA FROM 1966 UNTIL 1968, AND HAD WORKED ON A TEMPORARY BASIS FOR ABOUT TWO DAYS WITH AN ATTORNEY OF ITALIAN EXTRACTION, NAME UNRECALLED. WHILE WORKING FOR HIM SHE HAD TYPED A LETTER, CONTENTS NOT REMEMBERED, ADDRESSED TO THE MOTHER OF LEE HARVEY OSWALD, AND THAT MONEY WAS BEING SENT TO HER. REASON FOR THE MONEY TRANSMITTAL WAS UNCLEAR, BUT SEEMED TO HAVE SOMETHING TO DO WITH PRESIDENT KENNEDY'S ASSASSINATION. SHE HAD REFERRED TO ATTORNEY AT, "SLEEZE BALL" IN AN EARLIER CONVERSATION WITH THE COUNCILMAN'S SECRETARY, SAME DATE AND STATED THAT HE SHOULD HAVE BEEN INDICTED.

THE FEMALE ALSO INDICATED THAT SHE WAS IN THE NEW ORLEANS AREA DURING THE TIME OF THE CLAY SHAW TRIAL AND HAD BEEN INTERVIEWED BY THE NEW ORLEANS POLICE DEPARTMENT, BUT DID NOT WANT TO TESTIFY IN THIS MATTER BECAUSE SHE WAS AFRAID TO BECOME

INVOLVED. AS RECEIVING OFFICES ARE AWARE, CLAY SHAW WAS TRIED AND ACQUITTED BY FORMER DISTRICT ATTORNEY JIM GARRISON FOR CONSPIRACY TO MURDER PRESIDENT KENNEDY IN THE LOCAL COURTS.

GIARRUSSO ADVISED THAT THE FEMALE CALLER FORMERLY HAD BEEN MARRIED TO AN AMERICAN AND HAS A TWENTY-ONE YEAR OLD SON ATTENDING A LOCAL UNIVERSITY.

REQUEST OF LEGAT LONDON: IDENTIFY SUBSCRIBER TO TELEPHONE NUMBER 0273-304-361, AND CONDUCT BACKGROUND IN ATTEMPT TO IDENTIFY FEMALE CALLER. PRIOR TO ANY INTERVIEW, LEGAT SHOULD PROVIDE IDENTITY OF SUBSCRIBER AND FEMALE CALLER TO DALLAS, NEW ORLEANS, AND FBIHQ FOR INDICES CHECKS.
