Sweeney IC	R8261-4 (S) FLORENCE CARLYLE of King Travel Organization, Inc. called FELIX CUMMINGS to advise him that she had received a long distance call from Mrs. MARSINCHAB(ph) in Racine, Wisconsin, who wants to go to British Guiana to join her husband for Christmas. FLORENCE told CUMMINGS that Mrs. MARSINCHAB wanted to go to British Guiana on 12-21-63 which is not possible but revealed that she had booked her aboard a BOAC flight on 12-28-63. CUMMINGS asked FLORENCE to make other arrangements which would allow Mrs. MARSINCHAB to reach British Guiana in time for Christmas and suggested that attempts be made to get Mrs. MARSINCHAB aboard the Argentine Airlines flight which will leave NYC on Saturday night (12-21-63) at 7:30 PM enroute to Port of Spain, Trinidad, where she could get a connecting flight to Georgetown, B.G. early Sunday morning (12-22-63). 6:00	PM	John R. Sweeney IC	W5798-40 (S) SYLVIA CUMMINGS called FELIX CUMMINGS and they discussed the assassination of President KENNEDY which SYLVIA described as "a real tragedy." CUMMINGS told SYLVIA that "all I can say is that your country is very fascistic. They killed MEDGAR EVERS; they killed the President. It shows that they're a bunch of cannibals, that's all." CUMMINGS also spoke (S)

6:14	PM	John R. Sweeney OG	(S) [W5798-47] (S) [OLGA HOPE] called the Assistant Manager at the Hotel Lexington, telephone PLaza 5-4400 (by tape), and made a reservation for [a Guianese] official, the Honorable [FENTON RAMSAHOYE] whom she said is coming in on Tuesday, 11-26-63, at 3:55 PM. (S)
