SUBJECT WAS ASKED IF HE HAD ANY KNOWLEDGE OF OSWALD, OR THE JFK ASSASSINATION, THAT WAS NOT IN HIS BOOK. SUBJECT SAID ALL THE INFORMATION HE UNCOVERED, OR HAD PERSONAL KNOWLEDGE OF, WAS INCLUDED IN HIS BOOK. NOTHING WAS LEFT OUT AS HE INTENDS FOR HIS BOOK TO BE A CONCLUSIVE, COMPLETE HISTORY OF THE KGB'S ASSOCIATION WITH OSWALD, AND A HISTORICAL DOCUMENTATION OF THE KGB'S INNOCENCE IN REGARD TO THE JFK ASSASSINATION. ACCORDING TO SUBJECT, THE BOOK IS AN ACCURATE HISTORICAL TEXT, NOT AN ACTIVE MEASURE OR DISINFORMATION.

## RECOMMENDATIONS:
