SSC letter of 11/26/75, contained 28 requests for access. We previously have submitted 4 FBI memoranda dated 12/8/75, 12/18/75, 1/6/76, and 1/7/76, responding to these requests. This memorandum responds to the remaining Items that have been outstanding and which are mentioned in this memorandum. It is pointed out that in regard to Item 15, Eduardo Guevara is the subject of New Orleans file 134-905, Bureau file 105-92106, which file was opened on 3/18/66, and closed by New Orleans letter to the Bureau, 8/26/66, on the basis that Guevara was [a CIA contact] and had been a contact of that Agency since 1960. In regard to 16b, this has been coordinated with Inspector J. Allison Conely of the Inspection Division. He advised that the Attorney General was not in receipt of enclosed Item 16b, which is material disclosing the Inspection Division's additional inquiries. He recommended that this material be delivered to the Attorney General. A copy of this request is attached for information to the yellow of this communication.

Reference is made to SSC letter dated November 26, 1975, requesting access to various materials contained in FBI files.

This memorandum is to advise you that materials in response to Items 1, 15, 16b, and 26 have been assembled. In regard to Item 1, a thorough and extensive review of pertinent files did not reveal any material disclosing the results of an interview of Alonzo F. Hudkins, III, on or about January 3, 1964. However, a communication disclosing the results of an interview of Hudkins on February 8, 1964, has been located. This material is available for access.

In respect to Item 11, extensive research has been conducted and is continuing to locate material that would respond to this item. However, this research has not revealed any positive results. You will be advised in the event such material is located.

In regard to Item 15, a review of all references on Eduardo Guevara, also known as Eduardo Antonio Jose Guevara, Eduardo Antonio Guevara y Mourthe, Eduardo A. J. Guevara, did not disclose any FBI contact and/or interview with Guevara during the period between July 15, 1963, and November 22, 1963. The SSC request of November 26, 1975, Item 15, lists the name Eduardo Guevara. A search under this particular spelling did not reveal any material regarding a contact or interview during the pertinent period.
