A review of the files of the Miami Office reflected that by Bureau letter 4/28/61 to the New York Office, under the caption FPCC, the Bureau forwarded a letter dated 4/12/61 which was received from CIA. The CIA letter was classified SECRET. The CIA letter stated a fairly reliable source, not further identified, made available a membership list of the FPCC. The CIA source did not state where or how he obtained the list. A comparison of the CIA list and the one forwarded as an attachment to the referenced communication, reflected they were identical. (X)(u)

The above referred to lists, however, are not membership lists of the FPCC but rather a list of individuals who made a trip to Cuba in December, 1960 under the sponsorship of the FPCC. (X)(u)

On December 23, 1960 MANUEL ALVAREZ DE LA CAMPA, Traffic Supervisor, Cubana Airlines, who at that time was a PSI, made available a list containing 204 names. This list comprised the individuals who were scheduled to make the Christmas trip to Cuba aboard Cubana Airlines, the tour being sponsored by the FPCC. (X)(u)

The names on the list furnished by the Traffic Supervisor of Cubana Airlines were checked against the list made available as an enclosure to the referenced letter. It was determined that the two lists were identical. (X)(u)
