COLUMBIA SHOULD PROMPTLY DETERMINE IF (CO 80-C (FORMERLY CO 80-S) HAS ANY OBJECTION TO DISCLOSING HIS CONFIDENTIAL RELATIONSHIP WITH THE FBI DURING TESTIMONY BEFORE THE HSCA ON (JUNE 6, 1978.) IF HE HAS NO OBJECTIONS TO SUCH DISCLOSURE, THEN HE SHOULD BE TOLD THE FBI IS AGREEABLE. IF INFORMANT DOES NOT WANT HIS CONFIDENTIAL RELATIONSHIP REVEALED, ADVISE HIM THAT IF HE DESIRES, REPRESENTATIVES AT FBIHQ WILL BRIEF CONGRESSMEN LOUIS STOKES, CHAIRMAN, HSCA, AND SAMUEL DEVINE, RANKING MINORITY MEMBER, HSCA, CONCERNING INFORMANT'S SITUATION PRIOR TO INFORMANT'S APPEARANCE BEFORE THE COMMITTEE IN EFFORTS TO PREVENT QUESTIONING CONCERNING HIS INFORMANT STATUS.
