"The discussion was primarily of a social nature.

"DUWAYNE said that he is presently employed by a Tacoma ship
or boat building company and that he works in the molding
loft. He also said that he had purchased a 1949 green Chevrolet.

"During a discussion of the Young Democrats, DUWAYNE said that
DON and JOANNE should have contact with JANE KRAHL, as she is
a member of the same YD group. JOANNE said that while they
were cordial they had no opportunity to hold a serious political
