SUBJECT: HOUSE SELECT COMMITTEE
ON ASSASSINATIONS (HSCA)
REQUEST FOR BUILDING PASSES
TO JEH BUILDING

PURPOSE: To request that temporary building passes be issued to the six members of the HSCA listed below who regularly appear at FBIHQ pertaining to their assignments in reviewing pertinent FBI files. These passes would be temporary, for a period not to exceed 60 days since it is anticipated that full field investigation of these individuals will soon be requested by the Department of Justice.
