The source who requested his identity not be divulged and who furnished information concerning the discussion of the President's assassination at a meeting of the Industrial Club Organizers Council, Illinois CP, held on December 5, 1963, in Chicago, Illinois, is CG 5890-S, who furnished this information to SA BRYCE S. PLESNER on December 9, 1963.

The source who requested his identity not be divulged and who furnished information concerning the Hansborough Club meeting, Illinois CP, held in Chicago, Illinois, on November 24, 1963, which reflected a discussion of the assassination of the President, is CG 6366-S, who furnished the information to SA BRYCE S. PLESNER on November 27, 1963.
