It is noted that repeated efforts have been made by MEX-18 and MEX-19 to determine from ELIZABETH CATLETT (MORA (Bufile 100-395934; Mexico City file 100-939) all information which she knows regarding OSWALD but since MORA has been ill, it has been impossible for these informants to learn this information from her.

As soon as MORA is well, these informants will undertake to be with her, possibly on a trip for a two or three-day period, and will obtain from her all aspects of her knowledge regarding OSWALD. The information obtained will be reported immediately.
