[NY THREE NINE ZERO THREE DASH SIX] ON ELEVEN TWENTY SIX  
INSTANT, CONFERRED WITH GUS HALL, CPUSA GENERAL SECRETARY, IN  
ROOM SEVEN ZERO SEVEN, CHELSEA HOTEL, NYC. HALL STATED HE WOULD  
NOT VISIT CPUSA HEADQUARTERS DURING THE PRESENT WEEK FOR "SECURITY  
REASONS". HE STATED FURTHER THAT HE FELT THERE WILL BE AN  
ULTRA RIGHT ATTACK AGAINST THE CP IN VIEW OF THE ALLEGED  
INVOLVEMENT OF LEE OSWALD WITH THE FAIR PLAY FOR CUBA COMMITTEE.

SHORTLY AFTER THE INFORMANT MET WITH HALL, ARNOLD JOHNSON  
AND IRVING POTASH ARRIVED AT THE ROOM WITH TWO COPIES OF THE  
"NY WORLD TELEGRAM & SUN"  
~~"NY JOURNAL-AMERICAN"~~ FOR THIS DATE. BOTH WERE IN AN EXCITED
