AT MIGUEL ALEMAN, MEXICO

On 12-24-63 CARLOS RAMOS, Mexican Customs  
Administration stated that EDUARDO GONZALEZ, the Custom's Administrator  
would not return from Mexico City, DF until Jan. 2, 1964.

RAMOS stated he had located the original copy  
of the Temporary Entry Permit showing the entry of ANTHONY W. OSSWALD  
into Mexico at that Port of Entry on 9-27-63. It will be noted that  
the results of the inquiry in this matter had been previously made by  
SA ELDON E. HASTINGS on 11-26-63 and reported in his memo of 11-27-63.

It will be also noted that SA CROSSETT furnished the  
above info re OSSWALD TO BUFFALO by teletype dated 11-25-63.

RAMOS and other members stated this was believed to  
be the information which GONZALEZ wanted to furnish the FBI.
