Re Newark airtel to Bureau, 5/8/64.

By letter dated 8/3/64, the Newark Division furnished information received from NK 1913-B that subject is scheduled to speak in Newark, New Jersey, on 8/23/64. This information was received by informant at SWP meeting held 7/19/64, at which MURRAY ZUCKOFF, SWP member, commented that LANE has real proof that LEE HARVEY OSWALD did not kill President JOHN F. KENNEDY and that he, LANE, had interviewed a female witness who saw OSWALD at the time of the assassination but who was never questioned by the FBI.

No further details re site or sponsor of LANE's speech in Newark known at this time.

Newark is requested to determine all details re scheduled LANE appearance and attempt to provide
