On 4/30/64, [WF 279-S*] (S) furnished the following information:

ANATOLI F. DOBRYNIN, Soviet Ambassador to the U.S., advised LLEWELLYN E. THOMPSON, Ambassador at Large, U.S. Department of State, in part, that as regards the business on the OSWALD case, he hoped that they ((Russians?)) will give the documents which they spoke of, on Monday or Tuesday, and he will let THOMPSON know. (S)(u)
