Verification of whereabouts of NOI and Klan members.

On night of 11/22/63, CE 1949-S was requested to personally verify presence of all NOI members in Winston on 11/22/63, which he agreed to do before going to work at 7:00 A.M. on 11/23/63. At about 9:00 A.M. 11/23/63 informant called and said that he had personally talked with all noi members except on ( George X Fulp) and verified their presence in the city. He said that he had direct information Fulp was in town and working at a barbershop.

Mrs. Vivian Parris, Reynolds Building Cigar Stand advised 11/23/63 that L. J. Dowell was on duty and work at his regular job as janitor 7: A.M. to 4: 00 P.M. 11/22/63.

Thos. Z. Lauten, Mgr. Zinzendorff Laundry advised that RAY C. PERRYMAN, 136 Edgewood Ave. had worked all day as a driver on 11/22/63 and was working on 11/23/63.
