55-1 CI advised that he could not recall any particular person or persons with whom he talked on 9/27/63 in the coffee shop at the Dunes. CI said his records reflect that the American Motors Convention was started at the Dunes on 9/26/63, and was the only convention in progress on 9/27/63. CI said that so far as he could recall, the only person he knew in Dallas Texas, was a Mr. ROBERT MCNULTY, employed by the General Electric Company. CI said that he could not recall talking with anyone about a parade, a wedding, or anything similar to that set forth in the Anonymous letter. CI said that he receives numerous long distance calls each day from all part of the Country, in connection with his position as Director of Convention Sales at the Dunes. CI said that he talks with many people each day in the Coffee Shop. CI went to CG on or about 10/12/63, and then flew to Mexico City for 1 week on 10/18/63 to attend the
