On June 11, 1962, MM T-1, a Cuben business was which extensive contacts among Cubens in the Mianil, Florida exea, and some other exeas of the Middle Spaces, who has furnished reliable information in the past, stated that he had received the following information from a source whom he considers reliable who was recently in contact with Rolando L. Cubela y Secades in Cuba.

Cubela was one-time commandante in the Directorio Revolucionario (Revolutionary Directory), which fought against the regime of former Cuban President Fulgencio Batista. He also was one-time president of the Cuban University Student Federation (FEU).

Cubela has been designated by the Cuban Government to attend a Socialist Congress in Helsinki, Finland. He departed Cuba en route to Prague, Czechoslovakia, on June 10,

According to information made available by the source, Cubela has indicated that he plans to remain in attendance at the congress until it terminates sometime during the latter part of July, 1962. He then plans to return by way of Paris, France, instead of Czechoslovakia. He stated that he is desirous of remaining outside Cuba and defecting from the Cuban Government.
