Reference is made to our memoranda dated April 6, and July 9, 1959, concerning the subject. Reference is also made to Telegram Number 746 from the United States Embassy, Havana, Cuba, to the Secretary of State dated August 15, 1960. The telegram indicated that Cubela, President of the Cuban Federation of University Students, had departed Havana for Geneva, Switzerland, on August 14, 1960. telegram also indicated that Jose Venegas would accompany Cubela and that both are anti-American extremists who could be expected to criticize the United States during their trip.
