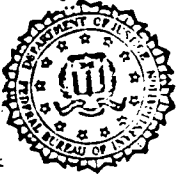

On August 15, 1960, a confidential informant, who has furnished reliable information in the past, learned from a source whom he considers reliable, that Major Rolando Cubela, President of the Federation of University Students in Cuba, arrived in New York City, from Havana, Cuba, on August 14, 1960. Several days thereafter, he departed for Switzerland.

The informant advised that when Cubela returns to New York City, he will stay there for several days before proceeding to Havana, Cuba. While in New York City, he will be in contact with the Cuban consulate, particularly Jose Vasquez Blanco, Consular Attache. (S)
