On July 3, 1962, MI T-1, a Cuban businessman with a large circle of acquaintances among the Latin American elements in the United States and Cuba, who has furnished reliable information in the past, stated that Rolando L. Cubela y Secades had advised a source in the United States that he will go to Paris some time around the end of August, 1962. He will remain in Helsinki, Finland, where he is attending a Youth Conference, until the conference is over, and then will go to Paris.
