MAMAN is on friendly terms with CARLOS PRATER, the current Commercial Attaché of the Cuban Consulate in Miami, and in January, 1960, furnished a copy of a letter from PRATER to the personnel of the Cuban Consulate in Miami with MAMAN's comments concerning a letter to the Miami Office for circulation. This letter was given to MAMAN by PRATER in delivery to the then incumbent Cuban Consul General for Miami named A. L. G. [REDACTED]. PRATER, at that time, was Consul at West Palm Beach, Florida, and BLANCO is married to MAMAN's half sister. MAMAN has also informed of a possible fifth column type infiltration of the Nicaraguan Government by CIA agents which has been reported to the Bureau by previous communication in a form suitable for dissemination. (S)

In view of the above and the fact that no specific information has been disclosed by investigation which reflects that MAMAN is acting as an agent on behalf of the Cuban Government, instant matter is being closed.
