ADMINISTRATIVE

Information copies have been furnished those offices reported to have delegations of the SNFE.

For the information of offices which have not previously received reports in this case, the Bureau, by airtel January 23, 1964, advised that in view of the interest of the Department of Defense in certain officials of the SNFE, coverage of the activities of the group should be confined to that coverage available through sources and informants.

This report has been classified CONFIDENTIAL, as it contains information from CIA reports, so classified.

Washington Field, by letter dated July 31, 1964, and Report of Special Agent HENDERSON HILLIN dated April 29, 1964, at Memphis, set out lead for Miami to review Immigration and Naturalization Service (INS) Caribbean Index regarding VERISIMO FRANCISCO SANCHEZ. Report of Special Agent JOSEPH H. KEARNEY, Memphis, dated September 29, 1964, set out information obtained from a review of INS, Memphis, file concerning SANCHEZ, including results of INS interview with SANCHEZ, and dealing with the fact that the name of SANCHEZ appeared on a list of doctors considered pro-Communist. As SANCHEZ continues to reside in Memphis territory, enclosed for Memphis is one copy of letter and letterhead memorandum dated October 25, 1962, which sets forth all available information concerning SANCHEZ.
