1. WE IN RECEIPT MEXI-7104. IT BEING PASSED TO ~~ODACID~~ AND ~~ODENVA~~ PER YOUR REQUEST.

2. HAVE DISCUSSED MEXI-7104 GENERALLY WITH MR. ALEXIS JOHNSON. HE WAFHUBASSADOR MANN TO KNOW THAT IT NOT LIKELY REQUESTED INSTRUCTIONS WILL BE FORTHCOMING PRIOR 28 NOVEMBER. ON WASHINGTON END ~~ODENVA~~ HAS JURISDICTION. BOTH ~~ODACID~~ AND ~~KUBARK~~ ATTEMPTING FOLLOW THEIR WISHES.

3. FOR YOUR PRIVATE INFORMATION, THERE DISTINCT FEELING HERE IN ALL THREE AGENCIES THAT AMBASSADOR IS PUSHING THIS CASE TOO HARD (SEE PARAGRAPH 5 OF MEXI-7104 AND THAT WE COULD WELL CREATE FLAP WITH CUBANS WHICH COULD HAVE SERIOUS REPERCUSSIONS. UNDERSTAND FROM MR. JOHNSON THAT HE SENT TELEGRAM ~~ODACID~~ CHANNELS TO AMBASSADOR THIS AFTERNOON ATTEMPTING TO GIVE HIM BETTER PERSPECTIVE ON THIS WHOLE PROBLEM. WE HOPE THIS WILL BE OF SOME ASSISTANCE IN REDUCING HIS PRESSURES ON YOU.
