STEPPING UP RECEIPT ALL INCOMING MATERIALS COVERING SOVEMBS, TRYING GET <sup>4</sup>LIP<sup>4</sup>EAT COVERAGE OF SWITCHBOARD OF APT BUILDING WHERE RESIDE MIN KAZANTSEV, SUSPECT KGB RESIDENT KONSTANTINOV AND SUSPECT GRU SHCHUCHKIN.
