The Select Committee requests access on a priority basis to the following materials on or before Monday, December 15, 1975:

1. All materials pertaining to Valeriy Vladimirovich Kostikov (or a known alias) either prepared during the period January 1, 1962 through December 31, 1965 or relating to activities of Kostikov during said period including operations involving or targeted at Kostikov and any contacts made by or on behalf of the Bureau.
2. All materials pertaining to Oleg Bryken (or a known alias) either prepared during the period January 1, 1962 through December 31, 1964 or relating to activities of Bryken during said period, including operations involving or targeted at Bryken and any contacts made by or on behalf of the Bureau.
3. All materials pertaining to the KGB's 13th Department prepared during the period January 1, 1962 through December 31, 1964 which relate to alleged or known activities of said Department in Cuba, Mexico or the United States.
4. All materials pertaining to an operation which we believe was code named "TUMBLEWEED," and which we are informed involved "double agent" contacts with the individuals mentioned in items 1 and 2 above
