Interview: Robert Genzman interviewed Joseph Goulden at his home concerning an article which Goulden wrote in the Philadelphia Inquirer on Decmeber 8, 1963, alleging that the FBI had tried to recruit Lee Harvey Oswald as an informant in 1963.

Goulden stated that he obtained the story from two sources--Dallas Deputy Sheriff Allan Sweatt (deceased) and an individual he declined to identify. He stated that Alonzo Hudkins was not a source.

Goulden stated that he relied on the word of his sources and never obtained any other evidence substantiating the allegation. He believes that his sources relied in part on the fact that FBI Special Agent James P. Hosty's telephone number was found in Oswald's notebook and possibly on the fact that an informant number was found among Oswald's possessions after his arrest on November 22, 1963. Goulden stated that his memory on these matters is unclear.
