Brickell Ave, Miami, FL, a former
prisoner of war, ~~who~~ was confined to
cell block # 7, Cebuana Prison, Havana,
Cuba. This cell block contained prisoners
who were the sons or heads of formerly
wealthy Cuban families.

Pujol's father paid \$100,000 ransom
to Fidel Castro in early 1962 to
obtain his release.

Pujol knew the subject of this rpt,
Pascu Organndez, who also was
confined to cell block #7.

Pujol said that Organndez told fellow
prisoners that he had participated
in the Bay of Pigs Invasion as
a member of the FBI, on orders by
the FBI, and that his status is
known by the Cuban officials.

Pujol said the prisoners considered
Organndez to be an informant to
the gov. officials. (Cuban officials).

Ovidio Kaba, born 11-20-27 in
Santiago de Cuba, belonged to the Bureau of
Investigations of the Cuban National Police
in 1950 & was a member of the Triple A,
the 26th of July Movement, and the OA
during the yrs. 1952-58.

He resided as of January, 1961, at Ave 9,
Number 8206, Marianao, Havana, Cuba.

On his return to Cuba, he was a 1st
Lt. and a member of the Technical Dept
of DIER, where he served under
Sergio Sanjinis from Jan to June, 1959.

He accompanied Castro to the U.S.
in April, 1959. He claims he deserted
in June 1959 to join with Chester L. Cayo
to org. a revolution in Nicaragua. Subj
was arrested & deported back to
Mexico after 17 days.

During his last 3 months in
Cuba, KABA was assoc. with the
AMBAR furniture store. KABA
was employed by the Russians during
this period to furnish the Soviet
Embassy in Havana.

KABA arrived in the US on 19 Nov 1960
via Ottawa. As of Jan, 1961, he
~~resided~~ resided at Hotel Monroe,
NW 27th St & 2nd Ave, Miami, FL.
At that time, he maintained contact
with Jorge Alonso Puig of the
FRENTE Revolucionario Democrático

Dr. Aragon said that rep. of "the Brigade" had been to Washington in early 1963 to speak with U.S. officials relative to the future of the Brigade - the rep. of the Brigade who were present in Wash during early Jan 1963 were Manuel Artur, Roberto and Jose San Roman, Comandante Olivera, Henry Ruiz Williams and Fina Ferrer. Aragon said that these ind. met with all Gen. Kennedy and Cottrell, Hurwitt, and Califano and 7 other individuals who comprise the Cuban Task Force.

- states that RFK developed a "great friendship" with Roberto San Roman who Dr. Aragon advised is not the individual the A & believes him to be & that this should be made clear. This friendship developed when RFK & General Maxwell Taylor conducted an inquiry into the reasons for the disaster of the Cuban Invasion of 1961.

Aragon said that it would appear that RFLK is listening to what Roberto San Roman & the Brigade has to say -

Dr. Aragon feels the individuals leading the Brigade pose great problems to Cubans generally because they are out for ind. fame & not general welfare.

Dr. Aragon said that on 1-17-63, he met with Joseph Califano at the Pentagon and stated 2 factors that greatly disturbed him

- 1) Cuban unity
- 2) Brigade

Califano said it could be difficult to ~~see~~ survey RFLK's opinion in making decisions based on Brigade info if the AG chooses to do so.

Dr. Aragon stated that one of the main difficulties in dealing with the Present Adm is that the various agencies of the U.S. listen to any Cuban who come to O.C., and without inquiring the nature of the Cuban, accept the info. After talking to the U.S. this Cuban returns home & says he has the backing of the U.S. gov. in the situation, & needs no org. because he ~~has his own org.~~ is his own leader with his own followers.

Aragon said this has repeatedly occurred.

of 1961.

After the Bay of Pigs a split developed in
the brigade - most of the brigade remained
loyal to Jose Mario Carbona, head
of the CRC, and their commandos.
Some, however, formed a small faction
critical of U.S. policy & behavior.
Jose Alonso Rujol part of this group

On 1-9-63, Jose Rujol advised
he was the director of the radio program,
"Giron Haba," which was critical of U.S.
policy.

Rujol was kept in the Principe
Prison.

-stated he was willing & able to do
anything to eliminate CASTRO & Communism
