22. HMMA-22307, dated 10/18/63 is the Operational Monthly report of Gregory D. Parmuth for the month of September. The HQ file number for this report is 50-6-18. Under the general ~~Summary~~ heading Parmuth wrote:

"Photographic BASEHOUSES COVERING SOVIET AND SATELLITE EMBASSIES produced normally with the exception of the LIEROPE BASEHOUSE which has ANOTHER ENTRANCE to COVER photographically.

This statement is explained under the section entitled Station Support. On 9/23 Parmuth visited the LIEROPE Basehouse to check the physical layout of the Cuban Consulate Building. This was necessary because the consulate entrance had been opened to the public a few days previously. The entrance had been closed in 1961 because

LITAIN "efforts using stretch devices." From 1961 to 1963 people visiting the Consulate had used the Embassy entrance. The base house photo agent, LIFUED-22 had been covering the Embassy gate with an Exacta Camera and a Bal-Scope since the Consulate had opened its doors ~~to~~ L-22 was having trouble covering both entrances. L-22 could not cover both entrances from one room. As of 9/23, the report says, about 70% of the visitors went to the Embassy gate and 30% to the Consulate. Parmuth discussed this problem with the Case officer Lawrence F. Barker. Barker requested additional photographic coverage. He added to the LIFUED basehouse to cover the Consulate entrance. An impulse camera was installed

on September 27, 1963. The equipment ~~was install~~ is described in detail in the dispatch. Two cameras were given to L-22 and he was briefed on how to hook them up to the triggering mechanism. L-22 was asked to test each camera for four days (8 days total). Parmouth says that "When satisfactory results of this testing become available to the Station, they will be forwarded to KURIOT POB for examination."
