File consists mainly of documents related to US v. Masferrer in Haitian invasion attempt. Very complete file. Indicates CIA knew about invasion and even that CBS was involved in filming the whole thing, but was not involved. Watched trial closely because of attempts by Masferrer to claim CIA support.

Defendants include Masferrer, Georges, Casey, et al, & Wurbell (sic) with note "LRH asked question of his - Wurbell's - having been reported to the govt on the existence of the conspiracy. Wouldn't this be good defense."

Father Georges now sole leader of invasion group. Luis Sierra instructed to get Masferrer to deliver all arms and ammo. According to David Cabeza, thru AMCUTLER-1, Masferrer submitted his resignation & offered to serve as soldier. Boat to be used SANDONA, COLUMBUS. Group rented house in Marathon, hangar in Marathon,

Enrique "Kiki" Masferrer Rojas died of heart attack 12/29
