- 3. Roselli started to Morgan by transpenn
- 4 - Mahan suspects Roselli in contact of Morgan
- 5 - Roselli doesn't recall; Morgan in Vegas recently "in contact"
- 6 - Garrison, Morgan, Roselli in Vegas in March. ^{business} In touch w/ Roselli; so was Morgan

It is our impression that Orensper also involved in the conversation.

^{prob} Point finger to Roselli as source of info and to ^{company} Morgan as Peasner's source.

Re Robt Mahan are strong non CIA participants with immediate knowledge of the Robert Kennedy report

^{prob} Summer of 62 - Edwards, Mahan, & Roselli had lunch & Edwards said he told Roselli he in found RFX of Roselli's contribution.

Peasner's story seems to rely on 7th spec. Could be Harry if ref 1 source.

Probably from 2 sources:

State Dept meeting + met Ogden re Roselli's chief suspect.

p127. We do not know that Castro actually tried to retaliate, but we do know that there were such plots against Castro. Unhappily, it now appears that Baum may also know this.

p129. Mahan reports that Tappan jail in Tampa. Roselli is prima non grata in her legs, being refused to register ^{with police} any form he is in form. None of them would have computations about digging in his C/PA connections when he was pulled by law enforcement authorities. Roselli has already done it when the FBI was nearby him in 1963. Roselli appears to be happy in his conversation with Thompson & Baum.
