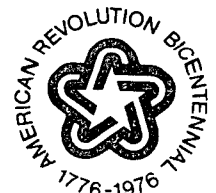
Dear Bert:

This is in response to your letter of June 25, 1975, concerning the request of Senator Frank Church, Chairman of the Senate Select Committee to Study Governmental Operations with Respect to Intelligence Activities, for permission for certain members of the Committee staff to examine classified defense material which is now among the Presidential papers in the John F. Kennedy Library.

You are hereby authorized to grant access to classified defense material in the files identified in the enclosure to your letter by the following Committee staff members each of whom currently holds security clearances as listed:

Please be advised that the classified defense material of concern must be protected as is required for material of the classification involved and that declassification review by the Department of Defense is required prior to public release, if any, of such material in whole or in part. The Department of Defense interposes no objection to your acceding to Committee requests for copies of documents containing classified defense material provided the copies are brought under control and afforded security protection as prescribed for safeguarding classified information of the particular level concerned and provided




the Department of Defense is furnished an inventory listing of the classified documents which are copied for and furnished to the Committee.

This authorization is not intended to supersede or alter any restrictions imposed by a donor with respect to records held in the John F. Kennedy Library and any questions concerning such restrictions are matters within the jurisdiction of the Archivist of the United States or his agents.
