



Dear Mrs. Davis:

During a recent visit to the Lyndon B. Johnson Library, Dan Dwyer and Michael Epstein, staff members of the Senate Select Committee on Intelligence Activities, conducted research among certain classified records and requested copies of selected documents. The documents have been transmitted to my office by courier service and are enclosed herein for review by the NSC staff before presentation to the select committee. This is a procedure agreed to by Steve Skancke in a telephone conversation with me on May 12, 1976.

Among these documents is a record of conversation with J. Edgar Hoover dated November 24, 1963. While this document is not presently classified, I believe that it should be reviewed by the NSC staff as probably containing classified information.

The select committee staff has expressed a sense of urgency and has requested that these documents be reviewed and conveyed to the committee as soon as possible. Would you please advise me of the outcome of your review.
