
Dear Mr. Blake:

In response to your letter of May 20, 1975, concerning a request by the Commission on CIA Activities Within the United States for access to CIA materials located in the Presidential library system, we have notified the directors of the various Presidential libraries and have asked them to cooperate with the Commission's representatives in any way possible. A copy of your letter authorizing access to the materials "regardless of classification" was included with our notice to the libraries.

Since CIA materials may be found in numerous files among a library's holdings, it will be necessary for a library staff member to work closely with the Commission's representative to identify the pertinent material and to correlate these materials with documents from other agencies whose permission for access has been sought and granted. Therefore, in order to facilitate access, Mr. David W. Belin, Executive Director of the Commission, should contact the library directors individually regarding specific arrangements for authorized members of the Commission staff to visit a particular library.

A list of the Presidential libraries, their addresses, and the names of their directors is attached. If there is any way in which I may be of further assistance, please don't hesitate to call.

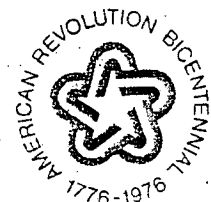
