T-1 advised that PAINE had been secretary-treasurer of the SWP in New York City prior to 1951 and is presently a member of the National Workers Committee and Regional Workers Committee of the Johnson-Forest Group. Several informants have advised of PAINE'S attendance at numerous meetings of the Johnson-Forest Group from 9/13/52 to the present time.
