SYNOPSIS OF FACTS.			

PAINT and wife were both reportedly members of the Workers Party from at least 1946 until the Johnson-Forest Faction joined the Socialist Workers Party and subsequently left that body in August, 1951 to helps form their own separate organization. PAINE considered to be a membel of the Los Angeles Local Johnson-Forest Group during 1952; known as member of the "Organization" during 1952 and 1953. In May, 1955, a vote was taken and passed that PAINE should no longer take an active part in the "Organization" to enable him, PAINS, to study the "Organization" from an impersonal view. PAINE considered one of the leaders of the Johnson Faction - Johnson-Forest Group in the U.S. as of September, 1955 and considered to be the chief financial contributor to that group. PAINE considered a member of the Regional Working Committee and National Working Committee of the Johnson-Forest Faction as of July, 1953. PAINE considered to be a member of the Executive Committee of the parent organization of the Autobiography Club and Owl Club in 1952 and considered a national leader of the Johnson-Forest Tendency in 1952 and 1953. Financial contributions, attendance at Johnson-Forest Group functions, and statements made by PAINE set forth. PAINE considered to be the legal owner of the publication "Correspondence" as of September, 1955.
